Applications for research projects involving foreign assistance and/or collaboration in biomedical/health research are to be submitted by the Indian investigators to ICMR for approval of Govt. of India through Health Ministry's Screening Committee (HMSC). The International Health Division at ICMR is the Secretariat for HMSC. The Cases related to transfer/ exchange of human biological material for biomedical research/commercial purposes are received directly at ICMR and also referred for comments by the Offices of Directorate General of Foreign Trade and Drugs Controller General of India. No objection to the transfer of human biological samples on case by case basis is granted by ICMR on the basis of decision taken by a committee, duly constituted by DG, ICMR for the purpose. IHD supports and coordinates the international travel of Indian Scientists engaged in approved bilateral research projects under various memoranda of understanding or joint statements with other countries for joint discussions and/or undertaking research activity. IHD also coordinates activities under the WHO-Biennium Programme as specified by MOH & FW, GOI from time to time and also for facilitation of agenda items for world Health Assemblies, Executive Boards and Regional Committee.</p>
